Can I withdraw money?	<ul style="list-style-type: none"> You can't make any withdrawals or close the account during the fixed rate period. Shortly before your fixed rate period ends, we will send you details of how you can reinvest your savings with us or take out some or all of your money. If we do not hear from you, we will transfer your balance to a variable easy access account. You will continue to earn gross interest. Depending on how you choose to reinvest your savings, these will be available from 29/07/2027

Nottingham Building Society
