Can I withdraw money?	- You can't make withdrawals or close the account during the fixed rate period - Shortly before your fixed rate period ends, we will send you details of how you can reinvest your savings with us or take out some or all of your money. If we do not hear from you, we will transfer your balance to a variable rate easy access account. You will continue to earn gross interest. - Your funds will be available on 01/11/2027
