Can The Nottingham change the interest rate?	Your interest rate is fixed until 31 January 2021. This means that we cannot change the rate until after this date.

How do I open and manage my account?	<p>To open this account:</p> <ul style="list-style-type: none"> • Visit any branch of The Nottingham • You must be over the age of 18 and a qualifying building society member. Take a look at the additional information section or ask in branch for more details • You will need to be a UK resident • You will need to fill in an application form and provide proof of your identity and permanent address • You will need a minimum of £500 • You can open the account in your sole name or jointly with someone else - only one account holder needs to be a qualifying member • Once this issue has been withdrawn, you won't be able to pay any more money into your account. <p>Managing this account:</p> <ul style="list-style-type: none"> • You can operate your account from any of our branches • The most you can pay into the account is £750,000 • Fixed rate accounts are only available for a limited period. Once this issue has been withdrawn, you won't be able to pay any more money into your account • You can pay money into your account at any branch using cash, a cheque or standing order. • Our Faster Payment sort code is: 60-95-93. Once you have opened your account this sort code should be used with the 8 digit account number for all Faster Payments, BACS and standing orders. You will not be able to send payments via CHAPS. 		

Can I withdraw money?	<ul style="list-style-type: none"> • You cannot make withdrawals until after the maturity date • As we don't allow withdrawals you need to be sure you won't need to access your money until the account matures • Shortly before your account matures we will write to you with details of replacement products available. If we do not hear from you, we will transfer your balance to an account called Branch Instant, or an alternative account we consider appropriate at the time • If the account is in joint names, the correct number of account holders must sign to authorise a withdrawal.
Additional information	<ul style="list-style-type: none"> • There's no guarantee that the current difference between our fixed rates and general rates will continue. General interest rates may fall below or rise above the fixed rate • This account is only available to qualifying building society members. A qualifying building society member is someone aged over 18 who has held one of our savings accounts for at least the last 12 months or holds one of our mortgages, and has a balance of at least £500. Corporate savings and mortgages are excluded from qualification criteria. Where a member is a trustee (for example on behalf of a Young Saver), this balance will also be included as part of the minimum balance threshold.
